4. The customer shall keep all properties used by Wild Composure Adventures fixtures, fittings, furniture and effects in a clean and good condition and shall replace any articles which are destroyed or missing with articles of a similar kind and of equal value.

11. Due to teacher cancellations or other situations beyond our control, Wild Composure Adventures reserves the right to change bookings and shall inform the customer as soon as possible. Alternative arrangements will be offered but we do not accept responsibility for any costs incurred, including airfare.

12. In the event of a Wild Composure Adventure teacher, hosting, and venue hire cancellation:

- 50% of the deposit is returnable if cancelled 90 days prior to the retreat start date.

13. In the event of an individual Wild Composure Adventurer place cancellation by the customer:

- 75% of the total cost of the retreat is refundable up to 60 days prior to retreat start date.

- 50% of the total cost of the retreat is refundable up to 45 days ahead of the retreat start date.

14. Should a customer wish to cancel after 45 days, if Wild Composure Adventures are able to fill the cancelled place after the 45 day period, the customer may receive a 50% refund or transfer the retreat cost to another retreat.

15. Events with two or fewer participants registered may be rescheduled or refunded with the exception of a processing fee.

16. Wild Composure Adventures is not held liable for flight costs.

17. Wild Composure Adventures reserves the right to offer discretionary discounts and this does not affect the status of any guests who have paid the full price and no discount will then become due to them.
